Fibre Security

Wood fibre is a key ingredient in our products. We source our fibre from our own and other responsibly and sustainably managed resources within South Africa.

We manage our own plantations' sustainability by implementing environmentally sound principles and adhering to best forestry practices to help minimise any possible environmental impact. We also belong to Forestry South Africa (FSA).

PG Bison's plantations, North East Cape Forests (NECF) and Southern Cape are Forest Stewardship Council® (FSC®) certified. Our manufacturing plants are not currently FSC® certified.

Low Emissions

Internationally, urea formaldehyde (UF) is the most common resin used in wood-based panel manufacturing because it is both strong and cost-effective.

UF contains formaldehyde, a common organic compound (CH₂O) and volatile organic compound (VOC), occurring naturally throughout the world. Exposure to high levels causes watery eyes, burning sensations in the mucous membranes, skin rashes and allergic reactions. Excessive, prolonged or long-term exposure is speculated to be carcinogenic by some authorities.

As resin technology improves over time, emission levels are reduced. Emission levels also decline with age. By surfacing particleboard or medium density fibreboard (MDF) with a high pressure laminate (HPL) or with melamine-impregnated decor paper as a melamine faced board (MFB) and sealing the edges with edge banding, formaldehyde emissions can be reduced by as much as 95%.

Free formaldehyde, from the production of wood-based panel products, is measured according to international test methods.

Formaldehyde Potential (Perforated Value) in accordance with EN 120:

Class 1 (E1):	≤8mg/100g
Class 2 (E2):	>8mg/100g but ≤30mg/100g

PG Bison manufactures E1 product on a Made To Order (MTO) basis. Please check with your local sales representative regarding availability.

PG Bison is the only manufacturer in South Africa able to test, certify and independently verify its own E1 board production in-house. This was made possible by enlisting the assistance of Fraunhofer, Europe's leading application-oriented research organisation. The independent, external authority audits the PG Bison laboratories biannually.

Local Fibre
The fibre content for all three sites is locally sourced. All sources of fibre used are strictly controlled and permitted by the Department of Forestry, Fisheries and the Environment (DFFE).



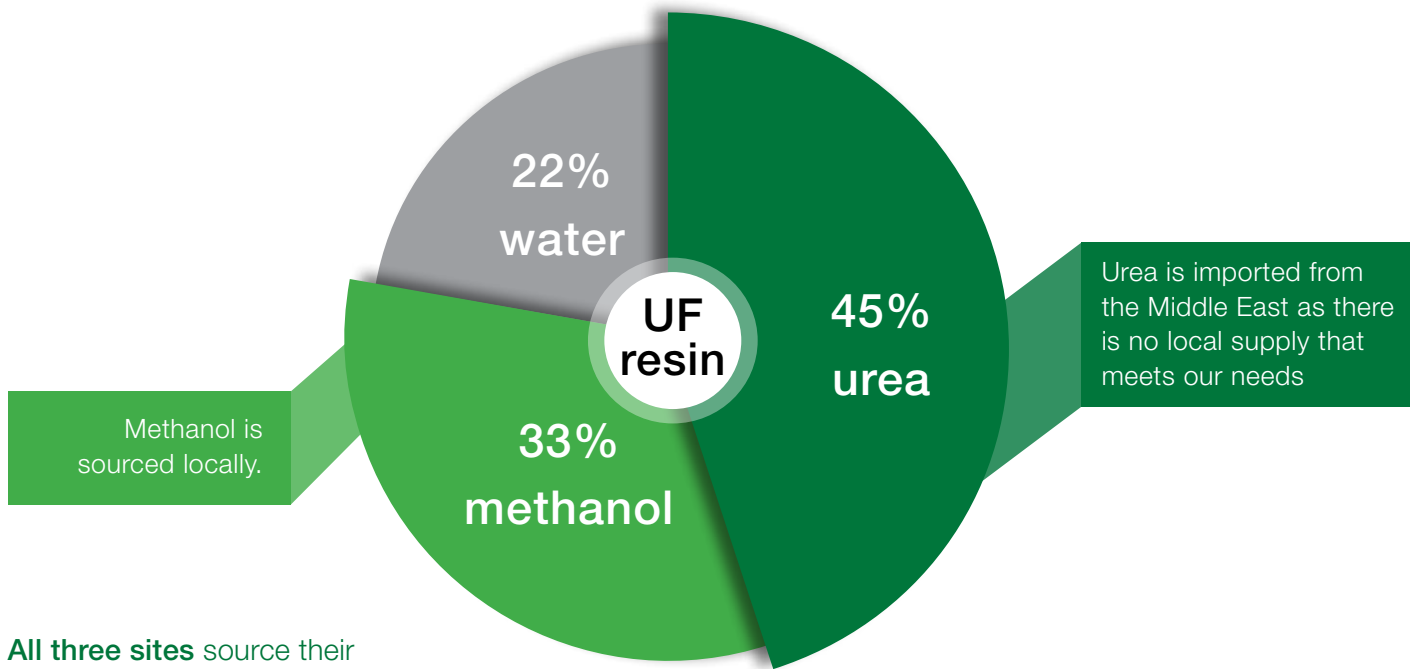
Decor Paper
The decorative papers for MFB are imported as there is no local supply that meets our needs. The decor paper is treated, at PG Bison's Paper Impregnation Plant (PIP), with melamine formaldehyde (MF) and UF resins, both produced locally by Woodchem. Decor paper adds < 1% to the total weight of the end product.



Proximity
The Ugie board plant sources fibre from its own plantations in the surrounding region as well as post-industrial activities. The Boksburg and Piet Retief board plants source fibre from third party plantations and post-industrial activities, in close proximity to the sites.



Resin
The remainder of the board's weight is made up by additives and UF resin to bind the fibres together.



All three sites source their UF resin from PG Bison's sister company Woodchem, located in Piet Retief.

PG Bison is a member of Proudly South African and has been verified as utilising a 95% level of local content and local labour in its production processes and activities.



PG Bison is committed to educating and upskilling individuals to assist them in having a brighter future. In support of this, we conduct learnerships, apprenticeships and internships across various areas within the business.



Broad-Based Black Economic Empowerment (B-BBEE)

B-BBEE is a government-led initiative aimed at transforming the South African economic landscape and achieving the upliftment of its society.

PG Bison is proud to be the first and only wood-based panel manufacturer in South Africa to have undergone the audit and receive verification of its B-BBEE status.

Responsibility

Our own success is inextricably linked to the sustainable growth and development of the communities in which we operate. We invest in programmes to empower these communities through their own development.

We concentrate our efforts on the most impoverished communities around us, focusing on technical, social and life skills development; grassroots sports development; and environmental educational and sustainability issues.

We partner with non-profit organisations, local farmers and businesses to establish programmes like feeding schemes, which in turn support local crèches, by distributing meals to pre-school children. PG Bison's product standards are ensured by extensive research and testing, and by using only quality materials in our production processes.

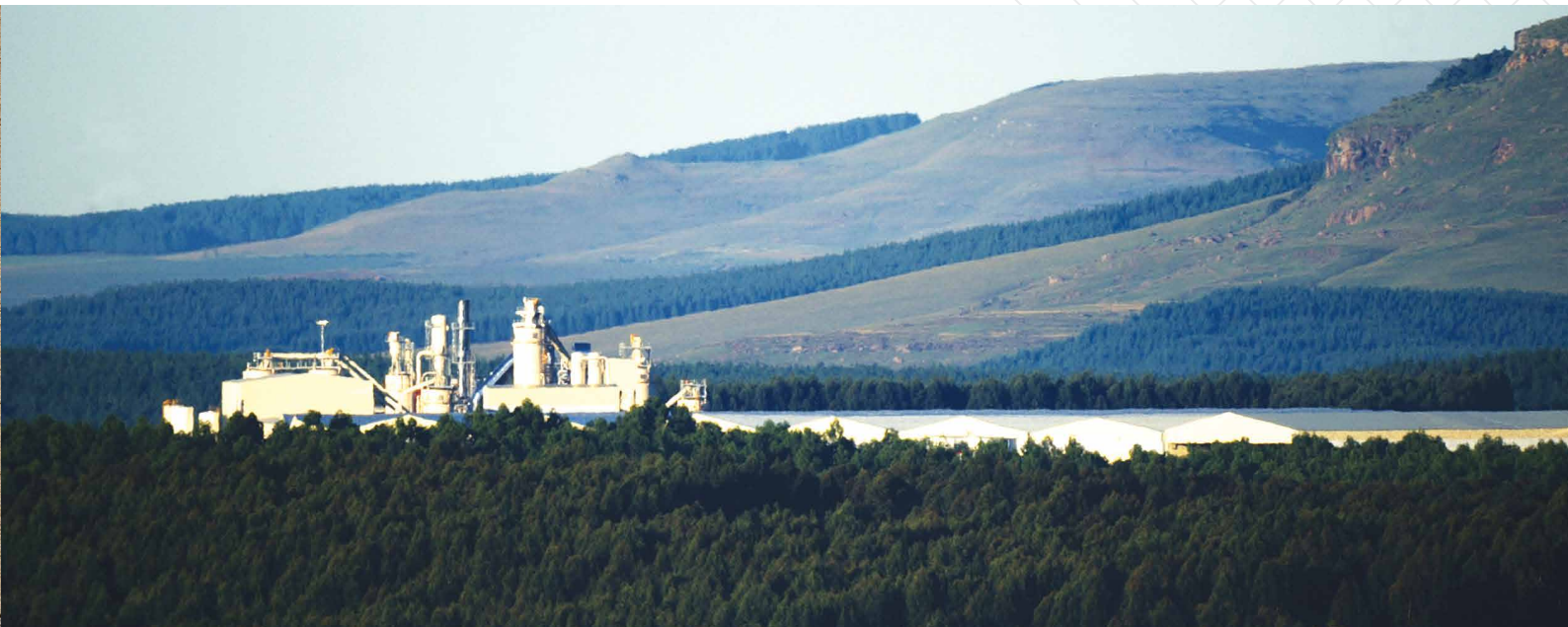
